1. All tickets, vouchers and other documents relating to transport, accommodations or other services and facilities (hereinafter referred to as "the travel services") issued by or on behalf of SURFER PARADISE (hereinafter referred to as "the company") only as agents for the concerns with whom the company may have arrangements for its clients (hereinafter referred to as "the principals") and are issued subject to these terms and conditions and those of the principals,

2. We always do our best to make sure your holiday arrangements are satisfactory and we accept liability but only to the extent if any loss or damage sustained by you as a result of our gross negligence or that of our employees. However, we cannot accept liability of whatever nature for the acts, omissions or defaults, whether negligent or otherwise, of those principals providing services in connection with your holiday pursuant to a contract between yourselves and yourself (which may be evidenced in the issue of a ticket, voucher, coupon or the like) whom we have no direct or exclusive control. We do not accept any liability in contract or in tort for injury, damage, loss, delay, additional expense or inconvenience caused directly or indirectly by force majeure or other events which are beyond our control, including but not limited to war, civil disturbance, fire, floods, unusually severe weather, acts of God, acts of Government or any authorities, accidents to or failure of machinery or equipment,

3. Except where otherwise stated, a deposit is due within 7 days of booking confirmation. The balance of the total cost is due upon arrival in Panama City. (or such later date as shall be specified in writing by the

Panamanian corporation located in Panama. Any and all legal issues and proceedings are subject to the laws of the Republic of Panama.

8. In the event you leave the camp earlier than your reserved stay, there will be no refunds. If your early departure was due to a medical emergency, you will be given a credit towards a future stay.

9. The company shall not be liable in the event, due to climatic conditions, that satisfactory surf is unavailable or unsuitable for the client to participate in.
